RULES AND REGULATIONS FOR CORPORATE GOLF

1. ENTRY

- 1.1 All entries must be submitted to the organizer.
- 1.2 The organizer shall not place any advertisement, notices, posters or whatsoever inviting entries within SGC premises.

2. DRAW

- 2.1 The draw shall be made by the organizer, with indication of each player's handicap.
- 2.2 The organizer shall clearly record SGC membership number where applicable, failing which the non-member green fee will be charged by SGC.
- 2.3 The organizer shall forward a copy of the draw to the Golfing Section at least three (3) days before the competition day, failing which, SGC shall not be responsible for preparation of scorecard labels, golf bag tags and other services.
- 2.4 No major changes will be allowed after completion of the draw.

3. FORMAT OF PLAY

4. HANDICAP

- 4.1 Timesheet start: All players shall report to the starter 10 minutes before the starting time.
Shotgun Start: All players shall be positioned at their respective buggies 15 minutes before the starting time.

5. TEE-BOX

- 5.1 Men – White tee
- 5.2 Ladies – Red tee
- 5.3 Use of Blue Tee Box is strictly prohibited.

6. HANDICAP

- 6.1 The Organizer shall ensure that all the participants are capable of playing in accordance with the Rules of Golf and complete a round of 18 holes in accordance with the Pace of Play set by SGC.
- 6.2 A maximum handicap for men and ladies will be fixed at the discretion of SGC management depending on the course and the formats of play.

7. PACE OF PLAY

- 7.1 Maximum time for 18 holes play is 4 hours and 30 minutes (average 4 hours 15 minutes)
- 7.2 The organizer shall ensure that the attached pace of play guidelines shall be observed by each player in order to avoid undue delay and slow play.



8. RESTRICTION

SGC reserves the right to stop a player from continuing his / her play in the event of his / her failure to meet any of the conditions in (06), (07) and/or (11) hereof.

9. BUGGY DAMAGES

The organizer shall check and report any damage upon taking delivery of any golf buggies.

The organizer shall accept liability for any damages to the buggies and the repair costs. In the case of damages, the organizer shall make a pre-payment of S\$2,000.00 per buggy. If the repair cost is less than S\$2,000.00, SGC will refund the difference. If the repair cost is more than S\$2,000.00, the difference shall be reimbursed by the organizer to SGC upon receipt of invoice.

10. INDEMNITY

The organizer accepts and agrees that SGC shall not accept liability or responsibility for any injury, death and/or damage caused or attributable to causes beyond the control of the Club (including but not limited to terrorist acts). SGC specifically disclaims any liability for personal injury, death and/or property loss and/or damage to all relevant persons and their respective properties caused or attributable to causes beyond the control of the Club (including a terrorist act or acts) or for any disruption to access to the Club or its premises or facilities or any closure of the same time.

11. PERSONAL DATA

The organizer has read and agrees to the terms in the Club's Data Protection Policy, including as to how personal data may be collected, used, disclosed and processed, and confirm that all information and details of myself are true, correct and complete. Where the organizer has provided personal data of individuals other than the organizer, the organizer warrants and represents that they are validly acting on behalf of each of these individuals, and have obtained their individual consent, to disclose their personal data to the Club and for the Club to collect, use, disclose and process their personal data for such purposes as outlined in the Data Protection Policy.

12. REGISTRATION

- 12.1 Each player must sign in upon registration and a scorecard will be issued at this time.
- 12.2 The organizer is responsible for giving away any goody bags during the event.

13. DRESS CODE

SGC has a fixed dress code which shall be strictly observed in the Clubhouse, on both golf courses and practice areas.



14. COURSE CLOSURE / FORCE MAJURE

- 14.1 The course shall be declared closed if it is considered unplayable due to inclement weather or any other reasons at the discretion of SGC Management.
- 14.2 In the event of the closure of the course, there will be no refund / reduction in the amount of booking fee, administration fee, green fee, buggy fee and marker fee paid or payable.
- 14.3 The course shall be closed at 7.00 pm irrespective of whether all the players complete the round or competition. Any subsequent play or usage of any part of the courses or the driving range is strictly prohibited.
- 14.4 If the event has been rendered impossible to execute due to inclement weather, lightning, government restrictions, access closures, safety issues, or any other cause outside the organizer reasonable control, event will be rescheduled to a mutually agreed date, with all amounts paid credited towards the rescheduled event, less any unavoidable third-party or consumed costs.

15. CANCELLATION

Cancellation of the booking by the organizer shall be in writing and must be made at least 3 months before the date of the event. Otherwise, the cancellation charge will be 50% of the confirmed golfers stated in the application form.

16. REDUCTION OF FLIGHTS

Reduction of number of flights of less than 14 days shall render the organizer liable for the following charges based upon the number of flights or golfers mentioned in the application form;

17. OTHERS

- 17.1 There will strictly be no spectators permitted on the Golf Course.
- 17.2 SGC reserves the right from time to time to revise all the charges, terms and condition of competition without prior notice.
- 17.3 The courses are offered on the understanding that routine or extensive maintenance works may be carried out from time to time at the discretion of the Management.



CLUB RULES AND INFORMATION

1. BANNERS / SIGN-BOARDS

- 1.1 Banners and Sign-boards to be placed in the Club premises must have the prior approval of SGC's Management.
- 1.2 The organizer shall be responsible for the installation of the banners / sign-boards before the competition and removal of the same immediately after the competition without damaging the Club's property.
- 1.3 No nails, staples or screws shall be used on any parts of or premises of the Club.
- 1.4 No sticking of materials with masking tape / double-sided tape etc. to any surfaces of the Club premises / property.

2. HOLE-IN-ONE

- 2.1 Car prizes may only be displayed for Shotgun Event. The organizer shall liaise with the Golfing Section for a prior permission and arrangements.
- 2.2 The Club shall not be liable for any damage to the car(s).
- 2.3 Hole location of each hole shall be decided and fixed by the Club, unless otherwise approved by the Management.

3. LOCKER KEY

- 3.1 A locker key shall be issued when a player deposits their golf bag. After use, all players must return their locker key in exchange for their golf bag.
- 3.2 A charge of S\$40.00 per key shall be levied to the players who lose their locker key.
- 3.3 The organizer shall accept liability for non-payment of the charge by any player.

4. STORAGE OF PRIZES / GOODIES BAGS

- 4.1 A storeroom will be available. The organizer is allowed to bring in the items only one day in advance during off peak hours (after 4pm).
- 4.2 Due to our limited storage area, balance of items must be collected within three (3) working days after the event. Otherwise, the Club reserves the right to dispose of the balance.

5. GETTING TO THE GOLF CLUB

A gantry admission charge is applicable to each car / taxi entering Sentosa. Admission charges vary according to time period. The flat charge covers all passengers onboard the vehicle.
